PGY2 Ambulatory Care Residency

Our postgraduate year two (PGY2) ambulatory care pharmacy residency program contributes to the development of ambulatory care clinical pharmacists who can integrate into a variety of clinical settings and deliver effective, evidence-based, patient-centered care, and will be eligible for board certification.

The outcomes of the residency program include:

- Provide evidence-based, patient-centered medication therapy and disease state management
- Exercise leadership and practice management skills
- Demonstrate project management skills
- Participate in the development of pharmacy-based patient care services
- Provide medication and practice-related education/training
- Utilize medical informatics
- Conduct quality improvement projects and pharmacy practice research
- Demonstrate additional competencies that contribute to working successfully in the health care environment and collaboratively with interdisciplinary teams

Key Features...

Our program features a robust ambulatory pharmacy practice setting that encompasses key elements of primary care pharmacy practice. There are two primary care clinics for longitudinal continuity experiences, each served by two full-time pharmacists that independently manage drug therapy under extensive collaborative drug therapy management agreements and bill for services provided.

POSTGRADUATE YEAR TWO AMBULATORY CARE PHARMACY RESIDENCY

PeaceHealth Southwest Medical Center has had a PGY1 pharmacy residency program since 1996. Pharmacists have been practicing in the ambulatory setting at PeaceHealth since that time as well. In 2019, the PHSW pharmacy department and Family Medicine of Southwest Washington clinic leadership came together to offer a PGY2 in Ambulatory Care Pharmacy.

The purpose of this PGY2 ambulatory care pharmacy residency program is to build on Pharm.D. education and PGY1 pharmacy residency training to contribute to the development of clinical pharmacists in the specialized area of ambulatory care practice. PGY2 residencies provide residents with opportunities to function independently as practitioners by conceptualizing and integrating accumulated experiences and knowledge and incorporating both into the provision of patient care. Residents who successfully complete an accredited PGY2 ambulatory care pharmacy residency are prepared for advanced patient care, academic, or other specialized positions, along with board certification.

This goal of our residency program is to develop competent ambulatory care clinical practitioners who have accelerated their growth beyond entry-level professional competence in patient care and in practice management and have further developed leadership skills that may be applied in direct patient care positions in ambulatory care upon completion of the residency. We emphasize the development of the primary care ambulatory care pharmacist who can successfully practice in a variety of clinical settings and establish innovative clinical practice through exposure to both primary and specialty care topics.

FACILITY INFORMATION

Located in Vancouver, Washington and part of the Portland, Oregon metropolitan area, PHSW's history began a century and a half ago as St. Joseph's Hospital. Today, PHSW is a nationally recognized medical center serving the residents of Southwest Washington. FMSW is a community-based residency program that is part of the University of Washington School of Medicine-affiliated Family Practice Residency Network and sponsored by PHSW. FMSW has been recognized as a Level 3 Patient-Centered Medical Home, the highest level possible by the National Committee for Quality Assistance (NCQA) Patient-Centered Medical Home program. The clinic employs 24 medical residents, 24 faculty clinicians, 2 physicians assistants, 2 clinical pharmacists, and 1 PGY-2 pharmacy resident.

Pharmacists practice under a broad collaborative drug therapy management agreement through the state of Washington and are actively involved in management of a variety of disease states. Washington is one of the few states where pharmacists can bill as fee for service providers with commercial and state Medicaid plans.
